Submission Requirements

Proposals must include the following information:

- Presenter's complete contact information including Name, Professional Qualifications, Title, Agency/Organization, Address, Phone and Email*
- Format (Traditional Presentation or Hands-On Workshop)
- Interest Area / Topic
- Title
- Summary (50 words or less) for inclusion in the conference program (*please use clear and engaging language*)
- Description and outline of the presentation
- 3 clearly stated learning objectives
- Indicate whether you will be willing and equipped to present via a virtual platform if necessary
- Presenter bio and resume or CV*

**Requested for primary presenter and each co-presenter*

The complete proposal should be submitted electronically in either PDF or Word format to:
